TERMS OF USE

INTRODUCTION

These Terms of Use (the "Terms") are a legal agreement between you and Main Street Exchange Corporation ("Main Street Exchange", "we", "our", or "us") governing your access to and use of the Company's website located at mainstreetexchange.com (the "Site") and the services which Company agrees to provide to you in connection with the Site (the "Services").

If you accessing the Site or using the Service on behalf of a third party that has entered into Main Street Exchange's Online Services Agreement or a separate agreement with Main Street Exchange in connection with the Services ("Services Agreement"), your use of the Site and Services will also be subject to the terms and conditions of the Services Agreement.

BY REGISTERING FOR THE SITE OR SERVICE, OR BY OTHERWISE ACCESSING THE SITE OR USING ANY OF THE SERVICES YOU AGREE TO BE BOUND BY THESE TERMS AND THE CODE OF CONDUCT.

- 1. REGISTRATION. You may access certain online features of the Services through your account on the Site (your "Account"). You may log into your Account using a unique username and password. You are responsible for safeguarding your password and you agree not to disclose your password to any third party. You are solely responsible for any actions taken under your username. You agree that the information that you provide to Main Street Exchange about yourself upon registration of your Account, and at all other times, ("Customer Data") will be true, accurate, current and complete, and you further agree that you will maintain and promptly update the Customer Data to ensure that it remains true, accurate, current and complete. You may not impersonate any other person or use a username or password that you are not authorized to use. If you become aware of any unauthorized use of your Account, you agree to notify Main Street Exchange immediately at contact@mainstreetexchange.com.
- 2. YOUR CONTENT. - Applicable Law and Dispute Resolution. These Terms shall be governed by the laws of the State of Colorado without giving effect to any conflict of laws principles that may require the application of the law of another jurisdiction. If you feel that your complaint has been addressed incompletely, we invite you to let us know for further investigation. If you and Main Street Exchange are unable to reach a resolution to the dispute, you and Main Street Exchange will settle the dispute exclusively under the rules of the American Arbitration Association (www.adr.org) at its Denver, Colorado office. Any election to arbitrate by one party will be final and binding on the other. YOU UNDERSTAND THAT IF EITHER PARTY ELECTS TO ARBITRATE, NEITHER PARTY WILL HAVE THE RIGHT TO SUE IN COURT OR HAVE A JURY TRIAL. YOU AND MAIN STREET EXCHANGE AGREE THAT ANY ARBITRATION WILL BE LIMITED TO THE DISPUTE BETWEEN MAIN STREET EXCHANGE AND YOU INDIVIDUALLY. YOU ACKNOWLEDGE AND AGREE THAT YOU AND MAIN STREET EXCHANGE ARE EACH WAIVING THE RIGHT TO PARTICIPATE AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS ACTION OR REPRESENTATIVE PROCEEDING. Further, unless both you and Main Street Exchange otherwise agree in writing, an arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of any class or representative proceeding. Regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to the use of the Site or the Services or these Terms must be brought, if at all, within one year from the accrual of the claim or cause of action or be forever barred.

If any provision of these Terms is found by a court of competent jurisdiction to be invalid, you and Main Street Exchange nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of these Terms shall remain in full force and effect.

CODE OF CONDUCT

This Code of Conduct is a part of the Terms of Use governing your access to, and use of, the Services provided by Main Street Exchange. Capitalized terms used but not disclosed in this Code of Conduct have the meaning provided in the Terms of Use.
